Notice to Applicant

- You will be required to provide documentation (such as a driver's licence, passport or proof of age card) to prove your identity and age, as part of this application.
- Every dog over 3 months of age (other than those exempt pursuant to section 33 of the Act) must be registered.
- Payment of the relevant registration fee and any fee for late payment of the registration fee must accompany this application.
- Registration remains in force until 30 June next year and may be renewed for further periods of 12 months.
- The Registrar may refuse to register a dog if satisfied that the dog is kept in a kennel or used for a purpose in connection with a business that should, in the opinion of the Registrar, be registered under section 35 of the Act.
- The Council is required to maintain a public register containing information regarding dogs it registers. The information sought on this form which has been marked with a * will be included in the public register.
